☒ **We want to keep this process as simple as possible, while guiding them in the right direction.**

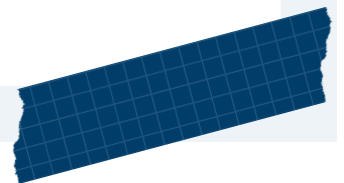
We don't want to require too much from students early on, hindering them from taking the initial leap into entrepreneurship.

What we recommend for all student owned businesses:

☒ TALK TO STUDENTS ABOUT SAFETY.

Our priority is the safety of our students, along with their customers! If their business proposes possible safety hazards, talk through those and make sure that necessary actions are taken to ensure the safety of everyone involved.

For student owned businesses that require additional licensing or certifications:

☒ HAVE A PLAN OF ACTION.

Food related student owned businesses must operate under the Cottage Food regulations. Georgia FLEX will provide those students with the ServSafe Food Handler course, provide food labeling education, and assist in obtaining water testing, if needed.

*For cosmetology related businesses, students must adhere to the laws pertaining to the Cosmetology License.
